The consumer recall page is designed to timely inform everyone about recalls that may occur in food, in more than 15,000 kinds of consumer products used in and around the home and in sports, recreation and schools, in motor vehicles and related equipment and in recreational boats and related equipment. The information is provided by the following various well known resource organizations: The United States Consumer Product Safety Commission, The United States Department of Transportation National Highway Traffic Safety Administration, The United States Coast Guard, The United States Department of Agriculture Food Safety and Inspection Service, The United States Food and Drug Administration and the Centers for Disease Control and Prevention.
