INCREASE RACK RATES EFFECTIVE MARCH 15, 2021

(*St. Croix, U.S. Virgin Islands*) –The Department of Licensing and Consumer Affairs (DLCA) Commissioner, Richard T. Evangelista, is notifying the public of the latest rack rate prices issued by Gulf Oil at Lime Tree Bay Terminal effective March 15 – March 21, 2021. Rack rate prices have increased since last published rack rates on March 5, 2021. The new rack prices with the .14/gallon tax effective Monday, March 15, 2021 are \$2.8100 regular, an increase of \$0.22. \$2.9000 for premium, an increase of \$0.21 and diesel (ULSD) is at \$2.5100, an increase of \$0.07.
