**DLCA TO HOST VIRTUAL PUBLIC HEARING ON RENEWAL LIQUOR LICENSES**

The Virgin Islands Department of Licensing and Consumer Affairs ("DLCA"), hereby notifies the public of two virtual public hearings to address community concerns on pending renewal applications for a Tavern Keeper A liquor license to conduct the proposed business activity listed as "1<sup>st</sup> floor bar sales of alcoholic and non-alcoholic beverages" on St. Croix, St. Thomas and St. John.

Pursuant to Title 8 of the Virgin Islands Code Section 13(c), DLCA may refuse to grant an application for alcohol license upon finding, after public notice and adequate hearing, that such refusal is in the public interest. DLCA invites all those property owners within residential areas, schools or churches that are 500 feet or less from the described locations, to present testimony either for and against the issuance of the aforementioned licenses to the DLCA.
