Pursuant to Title 8 of the Virgin Islands Code Section 13(c), the DLCA may suspend or revoke an alcohol license upon finding, after public notice and adequate hearing, that such suspension or revocation is in the public interest. The DLCA invites all those property owners within residential areas, schools, or churches that are 500 feet or less from the described location to present testimony either for or against the issuance of the aforementioned licenses.
