**DLCA ST. CROIX OFFICE ANNOUNCES TEMPORARY RELOCATION  
TO THE DIVISION OF PERSONNEL FEBRUARY 9 – FEBRUARY 27**

*(U.S. Virgin Islands)* Commissioner H. Nathalie Hodge of the Department of Licensing and Consumer Affairs (DLCA) is notifying the public that the Golden Rock office on St. Croix will be **temporarily closed from Monday, February 9, 2026 until Friday, February 27, 2026**, to allow for necessary remediation and sanitization work related to long-standing facility issues.

This temporary closure is part of DLCA’s ongoing commitment to maintaining a safe and healthy work environment for staff while ensuring continuity of services to the public. During this period, DLCA employees will be **temporarily reassigned to the Division of Personnel**, located at **3009 Orange Grove Shopping Center** on St. Croix, to support the continuation of essential public-facing operations.

“While this work is underway, the DLCA is taking proactive steps to minimize service disruption and ensure that consumers and businesses continue to receive timely assistance,” Commissioner Hodge stated. “This temporary transition allows for critical facility improvements to be completed while upholding our responsibility to the community.”

The DLCA will continue to provide updates as appropriate and encourages the public to also utilize available remote services and digital resources during this brief transition period. The Department thanks the public for its patience and understanding and extends appreciation to Director Cindy Richardson and the Division of Personnel for their spirit of collaboration and support.
